



Security



And role-based policy controls provide granular access privileges, segregation of duties and the ability to meet the data sovereignty requirements of GDPR. Finally, comprehensive auditing and reporting provide complete visibility into where files are stored, who is accessing them, and what's being done with them: viewed, downloaded, edited, or shared, etc.

With secure plug-ins for Microsoft Outlook, as well as Microsoft Office 365 online or desktop products, users can easily send sensitive content via email with a single click, or collaborate using familiar applications and save updated versions directly to all connected repositories. Intuitive interfaces allow access from a web browser, or via mobile apps for iOS or Android devices.

Automation & Integration

With connectors to popular ECM solutions located on-premise and in the public cloud, Kiteworks lets you keep your content where it belongs, but also find it easily from a single, universal interface.
